# Scope of the accessibility declaration

Limoncello di Capri S.r.l. with legal headquarters at Via Roma 89, Capri (NA), Italy operates in the Italian Food & Beverage sector producing the famous Limoncello DICAPRI. Limoncello DICAPRI adopts a processing method that involves controlling the entire production chain, from lemon to finished product.

Limoncello di Capri S.r.l. is committed to making its website limoncello.com accessible, in compliance with Law No. 4 of January 9, 2004. This accessibility declaration refers to the aforementioned website.

## Details on the evaluation methodology

The evaluation was carried out through an accessibility audit conducted with reference to the Web Content Accessibility Guidelines (**WCAG**) version **2.2** and Level **AA**.

The analysis involved a combination of:

- automated tools (Lighthouse, Silktide)
- code compliance review in accordance with WCAG 2.2 AA
- testing with assistive technologies that included (but was not limited to) use of Screen Reader, keyboard-only navigation, screen magnifiers, etc.

The analysis covered the fundamental flows of the site and in particular the pages representative of the templates used within the site.

## Conformity status

The analysis conducted on June 30, 2025, showed Partial Conformity with the WCAG 2.2 AA standard. Limoncello di Capri is committed to undertaking the necessary corrective actions to remedy the aspects identified during the analysis activity.

## List of non-conformities

The non-conformities present at the time of the analysis on June 30, 2025 and subject of our future activities include, for example:

### 1.1.1 - Non-text Content:

- Some of the images present on the site do not have a textual alternative
- Others do not have a meaningful textual alternative for the user

### 1.3.2. - Meaningful Sequence:

- The reading order of elements does not always correspond to the visual display

### 1.4.3. - Minimum contrast:

- Some elements do not present sufficient contrast between text color and background color

### 1.4.11 - Non-Text Contrast

- The contrast between some informative graphic elements and their background is not always sufficient.

#### 2.1.1 - Keyboard

- Some links and elements are not accessible via keyboard

#### 2.2.2 - Pause, Stop, Hide:

- Some elements animated for more than 3 seconds cannot be paused or hidden

#### 2.3.3. - Animation from Interactions

- Some interaction animations cannot be disabled

#### 2.4.4 - Link Purpose (in context):

- Some links do not have a meaningful name or alternative and/or internal text

## Preparation of the accessibility declaration

This declaration was prepared on September 14, 2025 following an Audit conducted on June 30, 2025 performed by a third and independent company.

## Actions undertaken as of September 14, 2025

The adaptation actions undertaken have affected the most problematic areas of the site. In particular, modifications and updates were made to the website code in order to intercept and resolve the most significant issues concerning the areas mentioned above.

For point 2.3.3, a site-wide approach was followed using the system setting **prefers-reduced-motion**, eliminating and reducing all avoidable animations due to user interaction (appearance of elements on scroll only, overly evident parallax effects, etc.)

In order to maintain the site in optimal conditions even following updates, continuous monitoring has been activated for a duration of 12 months from the date of preparation of this document to prevent content updates, automatic WordPress and/or plugin updates from causing any problems or reigniting already resolved issues.
